Application Guidelines for International Bachelor's Degree Program, Fall 2023

一、申請資格/I. Applicant Eligibility

申請資格悉依據教育部《[外國學生來臺就學辦法](#)》所規定辦理，辦法如經修正，將以教育部公告為準。

Eligibility is based on Ministry of Education (MOE) [Regulations Regarding International Students Undertaking Studies in Taiwan](#). If there have been any changes or updates to the regulations, the latest version announced by the MOE prevails.

● **國籍規定 Nationality Requirements:**

依據外國學生來臺就學辦法，你必須符合下列其一身份，方以外國學生身分申請本校：

According to International Students Undertaking Studies in Taiwan, You must meet ONE of the following requirements in order to apply for admission as an international student in Taiwan:

1. 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。

An applicant of foreign nationality who has never held Republic of China (“R.O.C.”) nationality and who does not have overseas Chinese student status at the time.

2. 具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者：

An applicant of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years.

- (a) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An applicant who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.

- (b) 申請前兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An applicant who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.

- (c) 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

Applicants referred to in the preceding two subparagraphs must have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year.

3. 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定限制。

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the

preceding two paragraphs if the competent education administrative authority gives approval.

4. 第二項所定六年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

The periods of six years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

5. 第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間不得逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term “overseas” used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

- (a) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by MOE;

- (b) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

Spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has MOE approval to recruit students overseas;

- (c) 交換學生，其交換期間合計未滿二年。

Spent a total period of less than two years in Taiwan as an exchange student; or

- (d) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

Spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.

6. 具外國國籍並兼具中華民國國籍，且於外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

An applicant who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to [Regulations Regarding International Students. Undertaking Studies in Taiwan](#) may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

● 學歷規定 Academic Requirements

1. 具國外高中學歷者，得申請入學本校學士班。

Applicants who apply for an undergraduate program must hold a certificate of graduation obtained from a certified foreign high school.

2. 須符合教育部採認規定之高中、大學或獨立學院畢業（[教育部外國大學參考名冊](#)），畢業（肄）業學校應為已列入參考名冊者；未列入參考名冊者，應為當地國政府學校權責機關或其認定之教育專業評鑑團體所認可。

Applicants must have graduated from a high school, college/university, or an educational institute that is either certified by [MOE](#) or has been accredited by an organization authorized by the government where it is located.

3. 具有教育部《[入學大學同等學力認定標準](#)》有關該學制同等學力報考資格者。

Applicants should meet the criteria under MOE [Standards for Recognition of Equivalent Educational Levels for University Admission](#).

4. 申請生之國外學歷依《[大學辦理國外學歷採認辦法](#)》規定辦理。

Applicants who graduated from the foreign countries should satisfy the provisions of the [Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education](#).

5. 外國學生依上述入學管道申請來臺就學，以一次為限。

An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying ONCE.

6. 曾因學校操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，則不得申請入學。

An international student who has been dismissed by the educational institution as a result of unsatisfactory conduct or of a conviction in criminal case proceedings is not permitted to apply for admission to another university or tertiary college.

二、學年度及修業年限/II. Academic Years and Study Period

1. 學年度 / Academic Years

每一學年起自 8 月 1 日至翌年 7 月 31 日止。秋季班約 9 月中旬開學；春季班約 1 月中旬開學。實際開學日期依本校行事曆公告為準。

The academic year begins on August 1 and ends on July 31 of the following year. Fall semester begins in mid-September, and spring semester begins in mid-January. Refer to the Academic Calendar of the University for the beginning date of each semester.

五、注意事項 / V. Important Reminders

1. 申請人應注意申請資格及申請系所之各項規定。

Please note that all applicant qualifications and requirements of the program should be met.

2. 外國學生凡已在國內完成申請就學或以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再向本校申請入學。若違反此規定並經查證屬實者，撤銷其入學資格。

An international student who is dismissed from a university or tertiary college after admission as a result of unsatisfactory conduct, or poor academic performance, or a conviction in criminal case proceedings is not permitted to re-apply for admission at this school. Verified violation of the rules on the applicant's part shall result in disqualification.

3. 已錄取之學生，如經發現申請資格不符規定或所繳交之證明文件有假借、冒用、偽照或塗改者，即取消入學資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明。如在畢業後始發現上述情事者，除勒令繳回撤銷其學位證書外，並公告取消其畢業資格。

If an admitted student is found disqualified, or the certificates or document as part of their application for admission submitted to be forged, fabricated, or that has been altered in some way, shall have their enrollment eligibility revoked. If the student has already registered and begun classes, their registration as a current student shall be cancelled and they will not be awarded any certification whatsoever regarding their related academic undertakings. If any such circumstances are first discovered after a student has already graduated, the eligibility to graduate shall be revoked and any degree already awarded shall be required to return and rescind.

4. 外國學生來臺就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。

International students who have the household registration, naturalization or restoration to R.O.C. nationality during their study will lose their international student's status and accept the discontinuation of their study by the University.

5. 錄取通知並不保證必定可取得入臺簽證，其審核仍依我國駐外機構決定。駐外機構可能要求申請人需另繳交中文或英文語言能力證書，詳情請洽當地臺灣辦事處。

The admission notice does not guarantee of issuance of a visa. A visa can be approved only by the Bureau of Consular Affairs, Ministry of Foreign Affairs or Taiwan Overseas Representative Offices. Some Taiwan Overseas Representative Offices may require the applicants to submit the Chinese Language Proficiency (enrolling in Chinese-taught programs) or English Language Proficiency (enrolling in English-taught programs) for visa application. For the requirement of visa application, please contact the Overseas Representative Office of Taiwan in/near your country.

Personal information will not be disclosed to any third parties or used for other purposes without the authorization of the applicant or conformance to other laws or special regulation.
